VALUATION TOOL AND CAR PURCHASE

Any valuation generated by the Valuation Tool (an "Online Valuation") is based on the information you tell us about your car (the "Car") and on the following general assumptions we make about your Car (the "Assumptions"):

- MFK (technical control) is valid at least one year
- it is not an import car
- It had never an accident
- there are no major mechanical faults with the car;
- it has no damage, including interior and mechanical;
- it has an engine which starts and it can idle on its own, i.e. it is not a "non-runner";
- you have two sets of keys for the car.
- It has the service history book

You have the option to contact us if you have a car with special conditions beside what we assume.

An Online Valuation is not an offer by us to purchase the Car. It is simply a tool to enable you to estimate the value of your car and the price which we may be willing to pay for it.

We always carry out a physical inspection of the Car before we agree to buy it. After you have received an Online Valuation, you may book an appointment ").

If, on inspection of the Car at the Appointment, we consider that the value of the Car is affected by any aspect of its history or condition, including any unusual feature or customization or anything which affects or limits the Assumptions we made about the Car, which was not apparent to us when we gave the Online Valuation, the price that we may be willing to pay for it following an inspection (the "Price") is likely to differ from the Online Valuation.

In case that we couldn't value your car online, we will send you a personalized valuation upon your request.

We are not obliged to purchase any Car brought to an Appointment. We also reserve the right to cancel an appointment. We reserve also the right to not dealing with customers that are already dealers or if you are selling the Car for commercial purposes, e.g. in the course of a motor trade business). You are neither obliged to sell any car brought to an Appointment. We are also not obliged to come to the appointment. We give particular attention to come on time and showing up for the appointment. However, In case of not being able to come to the appointment for whatever reason and that we couldn't warn you in advance about cancelling the appointment or being in a delay, you have no right to ask for any reimbursement or to sue us for this cancellation or delay.

Price Guarantee

The online valuation of the cars is just a rough estimation of the market price according to our best knowledge. It is not a binding valuation. Our binding offer is only after seeing the car, inspect it and make a written offer.

Subject to our inspection of the Car (as explained further above), the Online Valuation estimation is guaranteed for seven days from the date on which we send it to you. The reason is that the prices are updated weekly and prices can change fast.

We don't guarantee to buy every car we value.

Purchase Contract

A binding agreement to purchase the Car will only be made between us once you have signed our standard written purchase contract (the "Contract"). The terms and conditions that apply to the Contract are the following:

1. you are legally capable of entering into a binding contract to sell the Car;
2. you are at least 18 years old;
3. to the best of your knowledge, information and belief:
 - a. you are the sole legal and beneficial owner of the Car;
 - b. other than in respect of any finance outstanding on the Car which you have disclosed to us, no person has any claim to the Car;
 - c. the mileage reading on the Car is true and accurate and the odometer has not been tampered with;
 - d. you have disclosed to us all matters which a prudent purchaser would want to know about, such as physical defects in the Car (e.g. if it has any material mechanical problems or damage);
 - e. all information supplied by you in respect of the Car (whether in obtaining an On-line Valuation, at any Appointment or otherwise) is true and accurate in all respects; and
 - f. the Car is registered in Switzerland
4. you are not (nor are you acting on behalf of anyone who is) selling the Car in the general course of business.
5. In the event that we discover (at any time) that any of the above representations are (or are likely to be) inaccurate, untrue or false then we reserve the right (at our sole discretion) to:
 - i. request any documentation or information we deem necessary to determine whether the above representations are untrue or false; and/or
 - ii. withdraw any offer to buy the Car with immediate effect; and/or
 - iii. to rescind any Contract with immediate effect; and/or
 - iv. (where appropriate) seek damages from you.

Hand-over Requirements

At the time of making the Contract, we will expect you to provide us with:

- all copies of the Car's keys you have;

- the Car's registration document
- the Car's service history (if any);
- the Car's user manuals (if any); and
- any accessories there may be such as a locking wheel nut, radio fascia or remote controls.

We will also expect you to remove any personal possessions from the Car once the Contract has been concluded. We will not be responsible for any personal items lost once the Car is in our possession.

In the event that you fail to comply with these hand-over requirements, you agree that we have the right to withdraw any offer to buy the Car with immediate effect, to terminate any Contract with immediate effect, and/or to indicate a revised Price at which we will be prepared to purchase the Car. If we elect to rescind the Contract, we will return the Car to you, and you will refund the Price to us.

Payment Options

We offer to pay the price of the car cash. However and depending on the price of the car, we have the right to offer you another payment method, like bank transfer.
